Bids (**Technical & Financial**) prepared in accordance with the instructions given in the Bidding Documents must be accompanied by a **Bid Security** in the shape of **CDR** for an amount of **3%** of estimated cost amounting to **Rs.375,000/-**. The Bids (**Technical & Financial**) must be delivered at the address given above on **26th November 2020** at **11:00 A.M.** The **Technical bids** will be opened on the same day and the same venue at **11:30 A.M** in presence of the bidder's / bidders representatives who choose to participate.

- The procuring agency may reject all bids or proposals at any time prior to the acceptance of a bid or proposal under Punjab PPRA Rules 2014 (Rule-35).

- No tender will be issued on the date of receipt of tender.
- Tendered rates and amount should be filled in figures as well as in words and tenders should be signed as per general directions given in the tender documents.
- In case the total tendered amount is less than **5% (Five)** of the approved estimated (DNIT) amount, the lowest bidder will have to deposit additional performance security from the Scheduled Bank ranging from **5.01% to 10%**.
