**WASA TENDER NOTICE FOR FRAMEWORK CONTRACT For
PURCHASE OF SODIUM HYPOCHLORITE SOLUTION WASA, LDA, LAHORE**

Water and Sanitation Agency (WASA), Lahore Development Authority (LDA) (herein after referred to as the "Client") intends to purchase Sodium Hypochlorite Solution for Disinfection of water distribution network through framework contract for one year (extendable) under Punjab Procurement Rules 2014.

2. Sealed bids are re-invited from the **Manufacturers of Chemicals / Importer / Authorized Dealers / Contractors**, duly registered with FBR and PRA (having NTN, STRN and PNTN) for the Purchase of Sodium Hypochlorite Solution (with available chlorine 19.5 to 19.9%) through framework contract basis for one year (extendable). The supply of solution will be as per requirement at WASA central store Main out fall road Lahore.
3. Bidding Documents, containing detailed terms and conditions, are available immediately after publication, at the office of **Director Procurement & Stores 59-F Gulshan-e-Ravi Lahore** and a complete set of bidding documents can be obtained on submission of written application / request along with payment of a non-refundable fee of **Pak. Rs.500 (Pak Rupees Five Hundred Only)**.
4. The Bids prepared in accordance with the instructions given in the bidding documents must be accompanied by a **Bid Security 2%** of estimated cost in the shape of CDR. Last date for purchase of bidding documents is **17th December 2019**. The Bids must be delivered at the address given above on **19th December 2019 at 12:00 P.M.** The bids will be opened on the same day at **12:30 P.M** in presence of the bidders / bidder's representatives who choose to participate.
5. The procuring agency may reject all bids or proposals at any time prior to the acceptance of a bid or proposal." Under Punjab PPRA Rules 2014 (Rule-35).
6. Conditional tender will not accepted.
7. No tender will be accepted which is received telegraphically or by post.
8. No tender will be issued on the date of receipt of tender.
9. Tendered rates and amount should be filled in figures as well as in words and tenders should be signed as per general directions given in the tender documents.
10. In case the total tendered amount is less than 5% (Five) of the approved estimated (DNIT) amount, the lowest bidder will have to deposit additional performance security from the Scheduled Bank ranging from 5.01% to 10%.
11. The bids will be valid for 120 days.
12. Estimated Cost **Rs.30-Million**.
