

WASA TENDER NOTICE

FOR

PROVISION OF HEALTH INSURANCE TO EMPLOYERS OF BS 01 TO 16 AND THEIR DEPENDENT FAMILY MEMBERS (CATEGORY B & C)

Water and Sanitation Agency (WASA), Lahore Development Authority (LDA) (herein after referred to as the "Client") invites the sealed bids from professionally as well as financially sound and well reputed Insurance Companies having AA+ rating from PACRA / JCR, registered with FBR (NTN) & PRA (PNTN) for Provision of Health Insurance to Employees of BS 01 to 16 and their Dependent Family Members (Category B & C).

2. The bidding documents are available immediately after publication (2014 PPRA Rule 25(1)) and can be obtained from the office of Director Procurement & Stores situated at 59-F Gulshan-e-Ravi Lahore a complete set of Bidding Documents can be obtained on submission of written application addressed to Director Procurement & Stores along with above mentioned documents (AA+ rating from PACRA / JACR), registered with FBR (NTN) & PRA (PNTN) and along with payment of a non-refundable fee of Pak. Rs.5,000 (Pak Rupees Five Thousand Only). Bidding documents shall be issued to owner of the firm by showing original CNIC and / or to Authorized representative of firm having authority letter with specimen signature of representative of firm along with original CNIC.
3. Single stage two envelope bidding Procedure will be adopted. Bids (Technical & Financial) prepared in accordance with the instructions given in the Bidding Documents must be accompanied by a Bid Security 3% i.e Rs.4,500,000.00 of estimated cost in the shape of CDR. Last date for purchase of bidding documents is 24 March 2020. The Bids (Technical & Financial) must be delivered at the address given above on 25 March 2020 at 10:30 A.M. The Technical bids will be opened on the same day and the same venue at 11:00 A.M in presence of the bidder's / bidders representatives who choose to participate.
4. Only technically responsive bidder will be qualified for opening of financial bid. Financial bids found technically non responsive shall be returned unopened to the bidders.
5. The procuring agency may reject all bids or proposals at any time prior to the acceptance of a bid or proposal. "Under Punjab PPRA Rules 2014 (Rule-35)".
6. Conditional tender will not be accepted.
7. No tender will be accepted which is received telegraphically or by post.
8. Tendered rates and amount should be filled in figures as well as in words and tenders should be signed as per general directions given in the tender documents.
9. The bid will be valid for the 120 days.
10. Estimated cost Rs.150 Million.
