WASA TENDER NOTICE FOR FRAMEWORK CONTRACT

FOR PROVISION OF QUALITY MEDICINE

Water and Sanitation Agency (WASA), Lahore Development Authority (LDA) (herein after referred to as the "Client") re-invites the sealed bids from professionally as well as financially sound and well reputed Pharmacies / chain pharmacies / medical stores having a valid drug sale license on form 9-A with category A for supply of drugs / medicines and surgical disposable on local purchase (day to day) through framework contract for one year (extendable) under Punjab Procurement Rules 2014 having at-least one branch covering entire town wise (*Gulberg Town, Ravi Town, Shalamar Town, Jubilee Town and Aziz Bhatti / Wagha Town*) jurisdiction of WASA Lahore, conveniently and easily accessible to WASA patients for the Provision of Quality Medicine on reasonable discounted rates on MRP.

2. The bidding documents, are available immediately after publication, (2014 PPRA Rule 25(1)) at the office of Director Procurement & Stores 59-F Gulshan-e-Ravi Lahore and a complete set of Bidding Documents can be obtained on submission of written application / request along with CNIC and payment of a non-refundable fee of Pak. Rs.50 (Pak Rupees Fifty Only).
3. Single stage two envelop bidding procedure will be adopted. Bids (Technical & Financial) prepared in accordance with the instructions given in the Bidding Documents must be accompanied by a Bid Security 30,000/- (Rupees Thirty Thousand Only) in the shape of CDR in favour of Director (P&S) WASA Lahore which is within 5% of estimated price. Last date for purchase of bidding documents is 23rd July 2019. The Bids (Technical & Financial) must be delivered at the address given above on 25th July 2019 at 11:00 A.M. The Technical bids will be opened on the same day and the same venue at 11:30 A.M in presence of the bidder's / bidders representatives who choose to participate.
4. Only technically responsive bidders will be qualified for opening of financial bids. Financial bids found technically non responsive shall be returned unopened to the bidders.
5. A bidder can participate in one Town or more than one Town, any bidder who intends to participate in more than one town he shall have to apply separately concerning issuance of bidding documents for each town if he has established Pharmacies / medical stores within the territory of relevant town.
6. Bidder are required to submit their best and final rate / discounts on MRP.
7. The procuring agency may reject all bids or proposals at any time prior to the acceptance of a bid or proposal. "Under Punjab PPRA Rules 2014 (Rule-35)".
8. Conditional tender will not be accepted.
9. No tender will be accepted which is received telegraphically or by post.
10. Tendered rates and amount should be filled in figures as well as in words and tenders should be signed as per general directions given in the tender documents.
11. The bid will be valid for the 120 days.
