WASA TENDER NOTICE

TENDER NO.P&S/25.01/6239 - CONSTRUCTION OF WASA HEAD OFFICE, M.A IOHAR TOWN LAHORE

- Water and Sanitation Agency (WASA), Lahore Development Authority (LDA) (hereinafter referred to as the "Client") re-invites the sealed Bids from Contractor / Firms / Companies having license from PEC in category C-3 or above with specialization in codes (CE-10 & EE-04), registered with FBR and PRA, for Construction of WASA Head Office, M.A Johar Town, Lahore.
- The bidding documents are available immediately after publication (2014 PPRA Rule 25(1)) and can be obtained from the office of Director P&S, 59-F Gulshan-e-Ravi Lahore and a complete set of Bidding Documents can be obtained on submission of written application addressed to Director Procurement & Stores along with above mentioned documents (PEC in Category C-3 or above with specialization in codes (CE-10 and EE-04), FBR (NTN) & PRA (PNTN) and along with payment of a non-refundable fee of Pak. Rs.5,000 (Rupees Five Thousand Only). Bidding documents shall be issued to owner of the firm by showing original CNIC and / or to Authorized representative of firm having authority letter with specimen signature of representative of firm along with original CNIC.
 - Single stage two envelope bidding Procedure will be adopted. Bids (Technical & Financial) prepared in accordance with the instructions given in the Bidding Documents must be accompanied by a Bid Security in the shape of CDR for an amount of 2% of estimated cost amounting to Rs.9,754,306/-. Last date for purchase of bidding documents is 21 May 2020. The Bids (Technical & Financial) must be delivered at the address given above on 22 May 2020 at 10:30 A.M. The Technical bids will be opened on the same day and the same venue at 11:00 A.M in presence of the bidder's / bidders representatives who choose to participate.
 - Only technically responsive bidder will be qualified for opening of financial bid. Financial bids found technically non responsive shall be returned unopened to the bidders.
 - The procuring agency may reject all bids or proposals at any time prior to the acceptance of a bid or proposal under Punjab PPRA Rules 2014 (Rule-35).
 - Conditional tender will not be accepted.
 - No tender via telegraph or by post will be accepted.
 - No tender will be issued on the date of receipt of tender.
 - Tendered rates and amount should be filled in figures as well as in words and tenders should be signed as per general directions given in the tender documents.
 - In case the total tendered amount is less than 5% (Five) of the approved estimated (DNIT) amount, the lowest bidder will have to deposit additional performance security from the Scheduled Bank ranging from 5% to onward (equivalent to percentage as quoted below of approved estimated cost (DNIT)).
 - The bids will be valid for 120 days.
 - The bidder shall fill up the bid schedule and indicate the percentage rate above or below the schedule of rates for the "scheduled items". No percentage premium will be quoted by the bidder against "Non-scheduled items" failing which the bid may be rejected.
 - Estimated cost Rs.487,715,265.00
