## TENDER NOTICE FOR

### ENLISTMENT OF PETROL PUMPS FOR VEHICLES / GENERATOR / INSTALLATIONS ETC (ZONE-II)

Water and Sanitation Agency (WASA), LDA invites the sealed bids from professionally as well as financially sound and Well Reputed Fuel Pump Stations / Fuel Companies, having valid License from OGRA and registered with FBR & PRA. (NTN and PNTN) under PPRA Rule 2014 for the Enlistment Of Petrol Pumps For Vehicles / Generators / Installations Etc (Zone-II) on reasonable discounted rates.

2. The bidding documents are available immediately after publication (2014-PPRA Rule 25(1)) at the office of Director Procurement & Stores 59-F Gulshan-e-Ravi Lahore and a complete set of Bidding Documents can be obtained on submission of written application alongwith payment of a non-refundable fee of Pak. Rs.5000 (Pak Rupees Five Thousand Only).
3. Single stage two envelope bidding procedure will be adopted. Bids (Technical & Financial) prepared in accordance with the instructions given in the Bidding Documents must be accompanied by a Bid Security 3% of estimated cost i.e Rs.3,150,000/- (Rupees Three Million Seven Hundred Fifty Thousand Only) in the shape of CDR in favour of Director (P&S) WASA. Last date for purchase of bidding documents is 06<sup>th</sup> August 2020. The Bids (Technical & Financial) must be delivered at the address given above on 08<sup>th</sup> August 2020 at 11:30 A.M. The Technical bids will be opened on the same day and the same venue at 12:00 P.M in presence of the bidder's / bidders representatives who choose to participate.
4. Only technically responsive bidders will be qualified for opening of financial bids. Financial bids found technically non responsive shall be returned unopened to the bidders.
5. A bidder can participate in tendering process if he has established petrol pump / filling station within the territory of relevant zone.
6. In case, the last date of bid submission and opening falls in / within the official holidays, the last date for submission and opening of the bids shall be the next working day.
7. The procuring agency may reject all bids or proposals at any time prior to the acceptance of a bid or proposal under Punjab PPRA Rules 2014 (Rule-35).
8. Conditional tender will not be accepted.
9. No tender via telegraph or by post will be accepted.
10. Tendered rates and amount should be filled in figures as well as in words and tenders should be signed as per general directions given in the tender documents.
11. The bid will be valid for the 120 days.
