- Single stage two envelop bidding procedure will be adopted. Bids (Technical & Financial) prepared in accordance with the instructions given in the Bidding Documents in presence of the bidder's / bidders representatives who choose to participate.
- Only technically responsive bidders will be qualified for opening of financial bids. Financial bids found technically non responsive shall be returned unopened to the bidders.
- A bidder can participate in one zone or more than one zone, any bidder who intends to participate in more than one zone he shall have to apply separately concerning issuance of bidding documents for each zone if he has established Pharmacies / medical stores within the territory of relevant zone.
- Bidder are required to submit their best and final rate / discounts on MRP.
- The procuring agency may reject all bids or proposals at any time prior to the acceptance of a bid or proposal. "Under Punjab PPRA Rules 2014 (Rule-35)".
- Conditional tender will not be accepted.
- No tender will be accepted which is received telegraphically or by post.
- Tendered rates and amount should be filled in figures as well as in words and tenders should be signed as per general directions given in the tender documents.
- The bid will be valid for the 120 days.
