The CSC in its meeting held on 20.06.2023 decided to approach the following four consultancy firms, considered from the list of firms already shortlisted by P&D Board for FY 2022-23 for the sector "Water Supply, Sanitation & Public Health Engineering", under PPRA Rule 46A:

1. M/s Eminence One (SMC-Pvt.) Ltd
2. M/s Enviro Consult (SMC-Pvt.) Ltd.
3. M/s JERS Consultancy (Pvt.) Ltd.
4. M/s Master Consulting Engineers (Pvt.) Ltd.

Accordingly, the abovementioned firms were requested, vide Nos. DMD(E)/353, 354, 355 & 356 dated 08.07.2023, to submit their willingness along with



necessary documents. Consequently, the following two (02) consultancy firms submitted their proposals, on closing date & time, to carry out the subject consultancy work:

1. M/s Eminence One (SMC-Pvt.) Ltd
2. M/s Enviro Consult (SMC-Pvt.) Ltd.

It was pointed out that under Rule 46A (a) of PPRA, the consultancy firm should be selected by considering at least three quotations from renowned, registered and well reputed firms on the basis of qualification and experience for the assignment, whereas only two consultancy firms, as mentioned above, have submitted their proposals to carry out the subject consultancy work. After detailed deliberations, the CSC recommended to re-initiate the hiring process under Rule 46A for the subject consultancy work. Moreover, it was decided that the proposals submitted by the aforementioned firms will be returned unopened / sealed.





