AMENDMENT

FOR

[Revised Tariff for Commercial, Industrial, Non-Residential and Bulk Sewer Users]

No.MD/480-83 dated: 20.06.2018 where it has been decided by the Authority in the public interest to revise the charges of Commercial, Industrial, Non-Residential and Bulk Sewer Users for the category of Private School / Colleges / Educational Institutions / Service Stations and Government Institutions w.e.f 1st September 2017 and whereas for the said purpose it is necessary to modify the relevant provision of the Notification No. MD/812 dated: 3rd August 2017. Now therefore Lahore Development Authority in exercise of power to conferred under section 28 of the Lahore Development Authority Act, 1975 (Act No.XXX of 1975) prescribes the following amendments in the said Notification No. MD/812 dated: 3rd August 2017 as under:-

1. Private School / Colleges / Educational Institution / Academies

- i. In item No. 12 of Para No. 02 the figure "50" shall be substituted by the figure "100".
- ii. Between the words charges and closing brackets the word and figure shall be substituted with "for every next slab of 100 students 25% of the consumption will be charged."

2. Bulk Sewer Charges for Government Institutions

In para No. 04 of the said Notification to the extent Government / Semi Government Organization etc (extracting / pumping ground water through Tube-wells installed) disposing of bulk sewerage into WASA Sewerage System rate shall be substituted as under:-

(Capacity)	(Rate per month) (Rs.)
- 1 Cusec	25,000
- ½ Cusec	12,500

(Rates to increase or decrease in Proportionate to the rate of one cusec)

3. Service Station etc


In Para No.05, item No.05 the figure "12,700" in column No.03 shall be substituted by the words "rate to increase / decrease in proportionate to the rate of 1 cusec as mentioned in Para No.04 of the said Notification."

NOTE: In case the tube well / ejector pump size is 0.25 cusec or above the higher of the rate will be charged i.e. calculated on the basis of Para No.04 or available within Para No. 05 of the tariff (except Private Schools / Colleges / Educational Institutions / Academies) of the said notification. In Para No.02 Sub- Para No.03 the sentence "per storey charges" shall be deleted.

4. Private School / Colleges / Educational Institution / Academies

- i. Para No. 05 item No. 12, the figure "50" shall be substituted by the figure "100."
- ii. Between the word charges and the closing brackets the word and the figure shall be substituted with "for every next slab of 100 students 25% of the rate will be charged."
